### III. FINANCIAL REPORT

Question: How many deed restrictions for the \$4,351 to lawyers?

Answer from Joe: 2 on-going deed restrictions

\$361 for policy changes in-line with State law changes \$500 to settle legal fees from 2018 from Board requirements

2021 spent total of \$314 through March 2021. The liability insurance is due in April and has been paid.

The annual assessment is \$10,360 and the budget must reflect that amount and so there is a non-descript amount to balance the budget.

Total balance between checking and CD is \$31,000

2-year reserve is required and available for operating expenses.
