REMINDER: Most homeowners moved into Woods Edge because of its beauty. The deed restrictions insure that the beauty is maintained. Some homeowners are not adhering to the deed restrictions. When property is purchased in our neighborhood a copy of the deed restrictions and bylaws is provided. These are contractual obligations property owners assume. The HOA Boards are given the task of making sure the restrictions are followed in order to maintain the beauty of the neighborhood and protect the financial interests of the HOA. The HOA Boards prefer to work with homeowners to keep our neighborhood beautiful and a wonderful place to live, instead of dealing with violations and using HOA funds for legal fees. Deed restriction enforcement is necessary to maintain our property values and quality of life.

If everyone adhered to the deed restrictions they agreed to, there would be no need for an HOA to deal with violations, less money would be spent, and the beauty of our neighborhood would be protected.

Please do your part and comply with the deed restrictions so that Woods Edge stays a peaceful, friendly, and beautiful place to live.


PET IDENTIFICATION TAGS
